Final Provisions

Subsidiary agreements, supplements and amendments to this agreement, as well as agreements on its cancellation, must be in writing in order to be effective. This also applies to the waiver of the written form requirement. There are no oral agreements between the parties. The place of jurisdiction is Rheinberg. The validity of this contract shall not be affected by the possible invalidity or ineffectiveness of individual contractual provisions. The same shall apply if the invalidity or ineffectiveness of a provision only becomes apparent at a later date. Both contracting parties undertake to replace void or ineffective contractual provisions by such provisions that come closest to the objective, technical and economic success intended by this contract.
